**Directions to event site-** Use google maps and type in HDDS-South. We are located at the intersection of Sierra Vista Rd and Cygnet Rd in Phelan. **From Hwy 138 east-** exit Phelan rd Left. Turn Right at Sheep Creek Rd. Left at Snowline Rd- (Before road curves to right). Right At Sierra Vista Rd and continue into the property at the end of the road, **From Hwy 138 West-** exit Sheep Creek rd on the right. Continue straight on to Snowline Dr (before road curves to the left), Right At Sierra Vista Rd and continue into the property at the end of the road. **From I-15-** exit Main Street and head west, Turn left on Sheep Creek Rd, Left at Snowline Rd- (Before road curves to right). Right At Sierra Vista Rd and continue into the property at the end of the road

### **Bitches in Season:**

Per Barn Hunt Association rules, bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their classes. There will be a sign indicating the BIS crating and potty areas. Entry fees for bitches that come into season will be refunded until the closing date of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If you bring a bitch in season, you must inform the trial committee prior to the trial and you are requested to inform all exhibitors at the daily briefings. Bitches in season must wear pants in the ring as well as at all other times when not pottyng. Please also inform the trial secretary so your running order can be adjusted.

## **General Info and Awards-**

- Please keep dogs on leash, stay on our property and clean up after your dogs.
- Please do NOT allow dogs to bark and disturb the neighbors.
- If you arrive before the gates open- please park on the left (EAST) side of the road and wait for gates to open

Dogs must have earned a RATO title PRIOR to registering for this event. All qualifying runs will count toward regular BHA Titles. Club Title Rosettes will be offered to any dog earning a title at this event.

**CUSTOM 2025 REGIONAL ROSETTES WILL BE AWARDED AS PER BHA RULES!**

All paper entries must be accompanied by correct entry fees (add \$5 for paper entries). Entries must have a Barn Hunt Association registration number. Forms submitted without a registration number will be returned. Any entries received before the opening date are not valid and will be returned or shredded. Entries received after the closing date will be waitlisted. A returned check does not constitute a valid entry and will incur a \$50 penalty. Send entries to the address listed on the front page and entry form, make checks payable to High Desert Dog Sports. No changes will be made after May 6th, 2025. Any refunds granted for any reason will be reduced by 3% due to unrecoverable credit card fees.

Managing Dogs- Are dogs are to be kept on a short lease and NOT allowed to go up to other dogs unless in the same family. Flexi leads, E-collars and head collars are not allowed AT ANY TIME while on the property, including before and after the trial.
