One Ring and One Judge. Open to all Breeds and Mixed Breeds of all Sizes.

Classes offered on Saturday and Sunday: Instinct, Novice, Open, Senior and Master.

Entries will open to Kerry Blue Terriers and Malinois dogs only on March 3, 2025. Open to all breeds on March 17, 2025. Entries will be accepted on a first received basis until limits are reached. If limits are not reached by closing (April 23th, 2025) we will accept Late entries until April 29, 2025 No Day of Show Entries will be accepted.

Any entries received before opening date **-will be destroyed.**

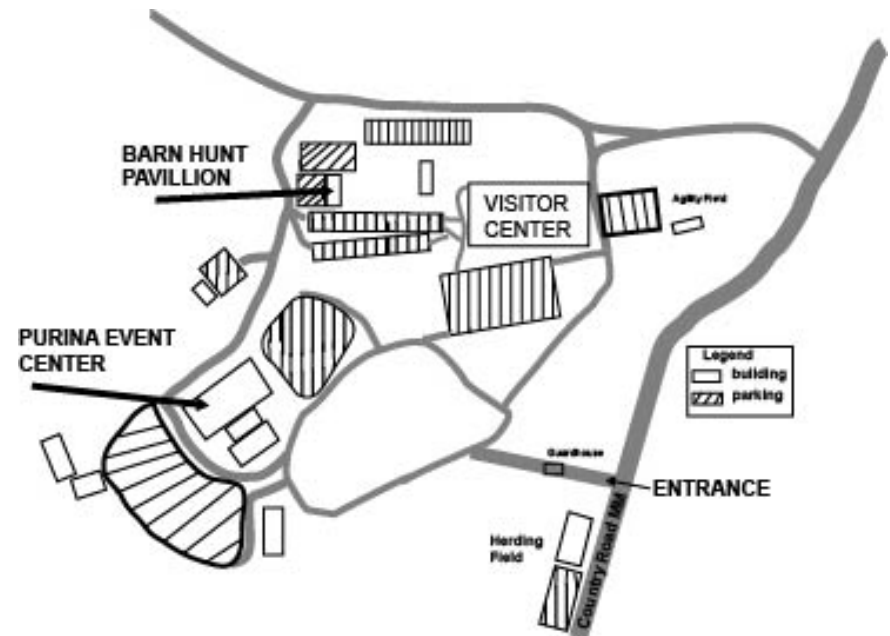

Entry fees are \$15 for Instinct, \$25 for Novice and Open and \$30 for Senior and Master.

Late Entries are \$20 for Instinct, \$30 for Novice and Open and \$35 for Senior and Master.

On both days there will be a short lunch break at the judge's discretion. Move ups will be allowed between days. Remember if your dog has passed the Novice title you cannot enter Instinct.



EXHIBITOR INFORMATION

Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct Test. For timing and judge loading the trial will be run in a non traditional order. The order will be sent out with the final confirmations. Move-up forms will be available at the Secretary's table. Move ups only between Saturday and Sunday's trials. All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or by e-mail.

Make check payable to MCAC. Send entries and fees to the trial Secretary. Refunds will be made in full if a dog is pulled before 4/24/24 pre-entry closing date but not after -except for a veterinary excuse.

Dogs must have a Barn Hunt registration number. You can auto generate entry forms from the Barn Hunt website. These need to be printed out, signed and mailed to the trial Secretary. Registration number, online entry forms and rules can be found at www.barnhunt.com.

AWARDS: Ribbons will be awarded for all qualifiers in the Instinct test and all regular classes. Ribbons will be awarded for first through fourth place for qualifiers in Novice through Master. High in Class ribbons and new title ribbons will also be awarded.

Kerry Blue Terrier awards: Celtic Knot Rat Pins: Judge's Choice awards to be awarded on Saturday and Sunday for All Breed, Malinois and Kerry Blue Terriers. Two Pins donated by David Poynter (Poynter Artworks).

Kerry Blue Terrier High In Class Rosettes in Regular Class for each Event. (Novice, Open, Senior & Master) Donated by USKBTC

USKBTC Challenge Mini Trophy will be awarded to the Kerry Blue Terrier with the most Qs and Best Time. (Multiple awards if there are Q ties in each class). These awards will be post event and mailed to winners. (Mini Trophies donated by USKBTC).

ABMC will offer laser etched insulated wine cups with straws for high scoring Malinois in all levels except Instinct. A special 'Danna award' will be presented at the banquet for fastest Novice Malinois sponsored by Janet Lasater. Also David Poynter will donate a Celtic Knot Rat Pin for Judge's Choice Malinois

These trials will be held outdoors under a pavilion. The blind is 10x20 and located either under the BH pavilion or in the parking lot next to the pavilion. Handicapped parking is available - please let trial secretary know if you need a space. There will not be a separate space for crating. You must crate your dogs in your vehicle. There is plenty of parking around the trial site. Please make sure your crate is secure as dogs may be highly excited and the nearby grounds are not fenced in.

Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial in panties. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. If bringing a bitch in season, please inform the trial secretary prior to the trial and inform all exhibitors at the judge's briefing.

Dog Aggression: Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found to do so by the judge and/or trial committee.
