Permission has been granted by the Barn Hunt Association, LLC, for the holding of these barn hunt trials under BHA Rules & Regulations.

Three rings w/two trials each day with these classes offered at each trial: Instinct (morning only), Novice A&B, Open A&B, Crazy 8s, Senior A&B, Master A&B on concrete in closed and open-air rings. There will be NO Line Drive class offered at this trial. Rings run concurrently.

Open to all breeds and mixed breeds, 6 months or older. All dogs must be registered with Barn Hunt Association to participate.

PLEASE READ: These trials are held at a working hobby farm. There are goats, a horse, and sometimes a peacock on site. **The trial site is about one mile from a shotgun firing range that shoots** throughout the week. There will be distractions. We WILL follow all current health/safety rules for a Washington State Agricultural event as well as Barn Hunt Association rules. If you don't want to follow the rules or deal with the distractions, please do not enter this competition. Please volunteer and be courteous to our volunteers. We put on these competitions to have fun with our dogs. Please make that your goal as well.

ABOUT OUR JUDGES: We may utilize load balancing or split judging to help with trial efficiency. Any judge of record at this event may be used to load balance in any ring. Qualifying scores will show the Judge who designed the Course. Judge of Record and Event Official dogs may be judged prior to the event start or as the first dogs of the Event. Judges

are limited to 8 hours of judging and a maximum run value, which may require this club to limit entries accordingly.

Late entries are \$5 more per level regardless of method of entry.

Day of Show entries will not be accepted.

Entries open on March 2, 2025, on a first received basis. We will continue to accept entries until limits are met or until April 21, 2025. Late entries are April 22 – April 27, 2025 and are \$5 more a run.

Electronic Entries: Secreterrier has a \$1/run Secreterrier processing fee at the time of payment with a \$10 cap.

SCHEDULE for FRIDAY, SATURDAY & SUNDAY

7:00 am – Grounds open

7:45 – 8:15 am – Measuring and Judges' blind

8:20 – 8:30 am – General briefing by Novice blind

8:35 am - First dog on the line

Second trial of the day will start as soon as possible after the ring for that class in the previous trial is concluded.

RUN ORDER: The club reserves the right to change the run order based on entries received and shall send the judging schedule prior to the start of the trial with confirmation. Dogs will be run in staged groups of no more than six (6) in Instinct, Novice, Open and five (5) in

everything else. Dogs being handled by the same person will be separated into different staging groups (blinds). NOTE: There are three rings. Master will have its own ring each day. Instinct, Novice and Open share a ring and Crazy8/Senior will share a ring.

MOVE UPS: Previous trial move ups must be submitted by Noon, April 27, 2025, via email. Same day move ups must be turned into the Secretary no later than 30 minutes after the last class of the first trial of the day. Next day move ups must be submitted no later than 30 minutes after the last class of the day. Exhibitors may also request lateral and move downs. Move Up/Down/Lateral forms will be available at the Trial Secretary window at the Office Barn.

BLINDS: 10x20 pop-ups will be used for all blinds. A doorbell system is planned to be used to call the next team to the arena to hunt.

Health/Safety: We will follow all local and state health & safety rules with information being sent out with your final confirmation as these rules can change quite frequently. If you are not able or willing to follow the local/state rules, please DO NOT enter this trial.

GENERAL EXHIBITOR INFORMATION

CRATING: All dogs will be crated in vehicles and must be on lead at all times when not actively hunting or in designated off leash area (not on Barn Hunt Grounds). There is parking within 100 feet of the hunting rings and all parking is first come first served with two handicapped reserved spots.

COLLARS & LEADS: No electronic collars, bark collars, muzzles or head halters allowed on Barn Hunt show grounds. Per Barn Hunt Association all pinch collars must be covered. SchaSam Farm does not allow flexi leads to be used on the Farm grounds.

BITCHES IN SEASON (BIS): May compete but must be run at the end of each class. BIS must wear pants at all times when not in their vehicle except when being pottied in the designated BIS potty area. Please inform the Trial Secretary prior to the start of the trial so your fellow exhibitors can be made aware of BIS present.

HEIGHT DIVISIONS: Small – Dogs 15” and under at the withers, Medium – Dogs 15.1” to 22” at withers, and Large – Dogs over 22” at withers.

DOG AGGRESSION: A judge or the trial committee may dismiss any dog behaving in a threatening or aggressive manner toward another

dog or person. Please report any issues immediately!

ANIMAL SAFETY: The safety of our dogs and rats are our primary concern. By entering these trials, exhibitors acknowledge they are familiar with the rules and regulations of this sport and that their dogs are familiar and physically able to perform all course elements.

GROUND: SchaSam Farm is 5 private acres with the Barn Hunt area utilizing about 2 acres of wheelchair accessible area. Barn Hunt grounds include all areas inside fenced in area before the house and up to any fences marked with pink tape. The entry to Barn Hunt grounds is at the entrance to the parking area from 268th.

AWARDS: Qualifying runs in Instinct receive a double flat qualifying ribbon. Novice through Master qualifying runs receive a double flat qualifying ribbon. Novice through Master placement ribbons will be awarded for 1st through 4th. A team earning a new title shall receive a New Title Rosette. The Club awards High in Class Ribbons to the dog receiving the best score in Novice A, Open A, Senior A, Master and Championship Classes. The Club will also award High in Class Ribbon for B Classes with more than four competitors. If a competitor receives a RATCH, RATCHX or higher RATCH title at this trial, they will receive a special RATCH ribbon. We also have Crazy 8 sashes available for those teams who earn their Bronze, Silver, Gold or Platinum awards.

REFUNDS & CANCELLATION POLICY: After the closing date, entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the trial committee.

Every attempt will be made to hold this event as scheduled. The club will refund all monies less what is needed to pay for unrecoverable costs if the event cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the event committee.

Abuse of any kind toward volunteers, dogs, rats, competitors, grounds, judges, or the trial committee will not be tolerated and will result in immediate dismissal from the event with no refund.

Withdrawals after the closing date due to injury of the dog will receive a 75% refund of paid entry fees. Request for refund must be accompanied by a dated note from a veterinarian and must be emailed or mailed to the Trail Secretary prior to the close of the trial on Saturday afternoon.

If you must withdraw due to suspected or a confirmed case of COVID-19

or direct exposure to/close contact with a COVID-19 patient, you will receive a full refund minus PayPal fees if you paid by PayPal.

REFUNDS & CANCELLATION POLICY (continued): If you do not follow all health/safety rules as outlined by BHA, SchaSam BH, or local and state governments, you will be asked to leave the grounds immediately, for the weekend, and there will be no refund of your entry fees.

RETURNED CHECKS: A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks.

SMOKING: Smoking is not allowed on SchaSam Farm except in your vehicle.

FOOD: Bottled water and packages snacks will be available for our volunteers. There are numerous coffee, fast food, diners & restaurants within a five mile radius of the Farm both east at the freeway exit to Stanwood and west in the town itself.

ON SITE CAMPING: By reservation: Dry camping is available for a limited number of small RVs, tents or car camping for \$10 per night. Porta potties and hand wash stations on site and access to water. Please contact SchaSamFarm@yahoo.com with basic info of your rig and arrival time.

NEW! SCHASAM'S OFF SITE ACCOMODATIONS: 4 electrical site RV camping spots off site at SchaSam Field are available (15 minutes north) as well as 3 bedrooms in the house there. Please contact SchaSamFarm@yahoo.com for reservations.

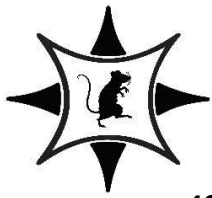
