**Day of entries will close at 8:00am for trials offered that day.**

**Ribbons and Awards** for first, second, third, and fourth place will be provided for each titling class. Rosettes will be given for new titles, RATCH, and REMX. High in class ribbons will be given to all A level classes and Master B. Novice, Open, and Senior B level HIC will be given to classes with 5 entries or more. Special awards will be given out for new titles in Crazy 8's.

## The safety of the dogs and rats is our primary concern.

Any dog behaving in a threatening or aggressive manner toward another dog or a person may be dismissed from the trial if justification is found by the judge and/or the trial committee.

As per BHA Rules, NO electronic collars, bark collars (including citronella), head-halters, uncovered prongs, or muzzles may be used on the grounds. All dogs must be on a fixed 6' or less leash and under control while on trial grounds.. No retractable leashes or long line leashes may be used.

**Bitches In Season (BIS)** may compete but they must wear well-fitted panties and potty in a designated area. BIS will run at the end of their class. BIS must crate IN their vehicle and display a sign that designates a BIS is present. Please inform the trial secretary as soon as you know your dog will be in season during the trial and as soon as you arrive on the grounds.

**This Event** will be held on private property which may not be handicapped accessible. Please contact the trial secretary if any special accommodations are needed. Barn Hunt Grounds will be the entire property minus the Private Residence which will be marked "off limits" by signage. Portable Restrooms will be available for people. Smoking/Vaping is not permitted on trial grounds. While food will **not** be provided on site, there are many restaurants available within a 5-10 min drive and food delivery services deliver to the site. The facility will close 1-hour after the last dog runs.

Dog potty areas will be marked and announced during the general briefing. Please do not let your dog potty on building walls, fences, trash cans or equipment.

**Volunteers** are a necessary part of a barn hunt event. We need all competitors to pitch in to help when you can. We are happy to do on site job training and fit you with a job you feel comfortable with. Most jobs are only 15-20 minute time commitments. Let the blind steward know where you are volunteering and they will locate you and make sure you do not miss your runs.

**Ring 1 & Ring 2** are located in the grey barn. It has rubber matted floor and each ring contains 1 support pillar. The rings are enclosed with 4' PVC/Lattice fence and solid barn walls. **Ring 3** is located in the classroom space and is on rubber matted flooring. The ring is enclosed with 4' PVC lattice fence.

## Blinds

**\*\*Please check in with your blind steward when you arrive so they know you are not absent.\*\***

Blinds are 10'x20' tents located outdoors, just outside ring entry. There will be 5 dogs per blind. Each competitor will be assigned a chair corresponding to their number in the blind. Competitors must exit the blind in order, not crossing the path of other competitors. **Dogs should be kept as quiet as possible in the blind.** Please report any dog aggression in the blind to the blind steward or any Trial Committee member. **Exhibitors are responsible for being ready to go in the blinds as soon as the last dog in the prior blind exits.** The club has no obligation to search for a dog not brought to the ring when required. You are expected to be outside waiting where the blind steward can see you when it is time to load.

If you have a conflict with another ring, please inform the blind stewards and they can tell you which ring should take priority and make any changes needed so you do not miss either run.

## Lodging

Clearwater casino is 10 minutes from the trial location and has dog friendly RV/trailer parking with full hook ups. Poulsbo Inn and Suites and Poulsbo Guest House are both dog friendly and are 5 minutes to the trial location. Please contact facilities directly for availability.

### Liability Waiver

I (we) agree that **Red Dog Ratters** has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to win prizes, ribbons, and/or trophies, I (we) agree to hold Barn Hunt Association, **Red Dog Ratters**, their members, directors, governors, officers, agents, or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any BHA LLC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog. In such case, no refund of any fees paid will be made. **Red Dog Ratters**, and its agents, volunteers, etc., will assume no responsibilities for any loss, damage or injury sustained by participants or spectators, or to any of their dogs or property and further assume no responsibility for injury to children. **Red Dog Ratters** reserves the right to decline entries for cause and may remove any dog on account of dog or human aggression. No one shall have any recourse or claim against **Red Dog Ratters**, or any agent thereof.
